

Privacy Policy and Protection of Data

The following Privacy Policy and Protection of Data document regulates the use of any type of person whether natural or judicial, or in any other form or representation, makes of the Platform and any of its Services which are property or are controlled by **REIMEX**. This document contains legal information. We advise that you read it thoroughly along with the Terms and Conditions document of the REIMEX platform.

The following "**Privacy Policy and Data Protection document**" is written to inform the members and Users of REIMEX about the manner in which this platform uses and processes its information, along with the objective of the data.

REIMEX states that it is in compliance with local and international laws, rules and regulations applicable to the protection of personal data, in specific the current law of data protection, Law Number 19.628 about the "Protection of Private Life."

Furthermore, REIMEX expresses its full approval of the dispositions contained in the General Regulations of Data Protection or (RGPD) from the European Parliament and the Regulations (UE) Number 2016/679 from the European Parliament and Council relative to *"the protection of the physical being with respect to the management of personal data and the free circulation of it."*

By approving the following "**Privacy Policy and Data Protection document**", it's assumed that the Users have read and accepted all the conditions mentioned in it.

The definitions established in the REIMEX Terms and Conditions are valid in their entirety for the Privacy Policy and Data Protection document.

I. Objective of data collection and management

REIMEX gathers, stores, uses and protects all the personal information which it receives from the Users, in accordance with the current legislation of Data Protection and the guidelines granted by this Privacy Policy.

The objective of the information gathered by **REIMEX** is to improve and update the contents and functionality of its platform so as to satisfy the requirements and needs of our Users. Furthermore, such information allows us to improve our communications with our Users, allowing a better management and administration of the services granted by our platform.

II. Data Gathering

REIMEX states that the information contained in the platform has mainly been gathered from sources of public nature and information received directly from the Users.

It's also possible that **REIMEX** may obtain non-personal information from the User in the interaction they carry out on the **REIMEX** website. This information is relevant to the data necessary to log on and register the account, along with all the relevant data needed to surf the site.

In case additional personal information or antecedent is required in order to use one of the services offered by **REIMEX**, the User will have to grant us express consent for the gathering of this additional data. It will be implied that consent exists by "clicking" in the box of the data treatment form that will display in case such information is required.

III. User Consent

The User may accept this "*Privacy Policy and Data Protection document*", by accessing the platform, where the document will be displayed, so it may be read.

After reading the "Privacy Policy and Data protection document" the User that continues using the Platform and services provided by **REIMEX** , expressively gives their conformity and consent, and agrees with the treatment of their personal data for the ends previously mentioned in this document.

In case of dissent, the User must abstain from accessing the Platform and using any of the Services, be it directly or indirectly, and stop using any information or additional service provided by **REIMEX**.

By accessing, surfing and registering as a User in the **REIMEX** platform, the User must first fill out the required data so that an individual account may be created.

The Users guarantee and are exclusively responsible for the truthfulness, accuracy, validity and authenticity of the information supplied at the moment of registry for an account on the **REIMEX** platform, having the obligation to periodically update the data, and communicating with **REIMEX** about the new modifications.

The User, by accepting this privacy policy, recognizes and understands that the information provided is that which is strictly necessary to individualize the account within the platform, so its uses are strictly regulated by the objectives in this privacy policy document.

IV. RIGHTS OF THE USER

- i. The User has the right to request the modification of erroneous, inexact, wrong or incomplete data which may be found within the **REIMEX** platform, the information must be corrected as soon as possible.
- ii. The User has the right to request the elimination or blockage of personal data which may be found in the **REIMEX** Platform, the information must be modified or blocked as soon as possible.
- iii. The User at any time may exercise the ability to, rectify, modify, oppose or interpose a complaint about the treatment of their personal data.
- iv. The User may eliminate or modify their personal data by sending an email to info@reimex.cl. If it's a Registered User, they may eliminate or modify their personal data from their REIMEX account.
- v. The User may cancel their account at any time by contacting info@reimex.cl. By deactivating the account, the User may request their back up data, and request the elimination of all their personal data from the platform.

Please take under consideration, that any modification, correction or elimination of the data won't be possible in cases in which a legal or judicial mandate prohibits this from happening, or if the data was obtained from a public source.

For the purpose of protecting the Users security and privacy, **REIMEX** has a commitment of taking reasonable and necessary steps in order to verify the identity of the User, so as to grant access to the account, therefore allowing modification or removal of personal data.

V. Safety of Information

REIMEX makes a commitment of adopting all the necessary security and confidential measures in order to protect the personal data given by the User, and avoid misuse, loss, theft, or unauthorized access to it.

VI. Third Party non-disclosure agreement

REIMEX states that all the information available on its platform, such as data, rating, reports and information, will be made available exclusively for internal use, and won't in any way borrow, share or distribute such ratings, reports, information or data to third parties outside the platform.

REIMEX won't sell, relinquish, transfer, rent or commercialize in any way the personal information from the Users on the platform, unless it's under direct obligation to do so, by law, administrative resolutions from a competent authority, or by a judicial sentence.

VII. Use of cookies

The User expressly authorizes **REIMEX** to use a digital filing cabinet of information known as "Cookies", in order to improve the services available in the platform and its correct functioning.

The User understands that the use of "Cookies" is useful and its objective is to facilitate and optimize the User's ability to surf and assist with the functioning and continuous improvement of the **REIMEX** platform, it also helps in identifying potential errors and problems within the platform.

Do to the necessary usage of the "Cookies" for the correct functioning of the platform, the User expressly accepts the use of "Cookies" when surfing on the **REIMEX** web page.

REIMEX won't be liable for the activities that third parties may carry out with the personal data obtained by the "cookies" used on the platform.

The cookies used by **REIMEX**, may use data bases for operating purposes are:

- 1. Underscore:** Saves a chain in 64 base formats, which represents the User's information once the User initiates session on the platform. This allows the User to access the platform and personalize their experience when using it.
- 2. Lang:** Saves the information about the selected language chosen by the User.

If the User won't agree with the installation of the cookies, they may at any time deactivate or destroy them, by using the internet navigator of their choice.

The cookies may be eliminated depending on the navigator used to access the **REIMEX** platform:

By accepting this privacy policy, the User grants **REIMEX** the right to store their data, and have permanent access to all the information in their **REIMEX** account, and also in general to all the information and content provided by the User on the platform.

REIMEX states that the personal data obtained will be stored with the sole purpose of abiding by the ends established in this document.

Furthermore, such personal data will only be saved if the User doesn't request the information be eliminated.

IX. Exclusion of Liability

The User that has accepted this Privacy Policy and continues using the platform, understands that such a use and navigation on the site is strictly their responsibility.

REIMEX won't be liable for any direct or indirect damage, loss of profit, emerging damage, incidental damage, special or consequential, deriving from the loss of information caused by the lack of confidentiality in the surfing or any use that the User may carry out on the platform, like any information transmitted through it, or any unauthorized exposure.

X. Changes in the Privacy Policy

REIMEX has the authority to modify its Privacy Policies at any time, always following the current legislation for the protection of personal data.

This Privacy Policy will be governed by the laws of the Republic of Chile
